

# 本會簡介

## About Us



**WBCSD全球聯盟**係集結全球各地超過60個由CEO領導之企業組織所組成的聯盟，大約有5,000家企業於此國際平台上共同承諾在各自國家與區域展現企業的領導力，一同致力於永續發展。

### The WBCSD's Global Network

is an alliance of more than 60 CEO-led business organizations worldwide. The Network, encompassing some 5,000 companies, is united by a shared commitment to provide business leadership for sustainable development in their respective countries and regions.

社團法人中華民國企業永續發展協會(以下簡稱本會或BCSD Taiwan)係由國內超過十種產業的大型企業所組成的非營利性企業組織，成立於1997年5月。本會會員企業對於追求經濟成長與善盡社會責任的重要性均有充分的認知，不僅自身積極落實持續改善環境績效的目標，並支持本會達成結合企業力量，提倡企業社會責任、推動環境保護及資源管理之理念及方法，以邁向企業永續發展並提高國人生活品質之宗旨。

本會為我國極少數積極參與國際社會永續發展活動之民間非政府組織之一，成立後旋即加入世界企業永續發展協會(World Business Council for Sustainable Development, 簡稱WBCSD)的全球聯盟組織，成為會員與國際社會相關企業組織間之橋樑。

The Taiwan Business Council for Sustainable Development (hereafter referred to as "BCSD Taiwan") is a non-profit business organization consisting of leading Taiwanese companies from across more than ten sectors. It was established in May 1997. The BCSD Taiwan's member companies deeply recognize the importance of the pursuit of economic growth and the fulfillment of social responsibilities. They actively implement the objective of continuous improvement of environmental performance and support the BCSD Taiwan as it seeks to integrate the strength of the corporate sector in the advocating of Corporate Social Responsibility, promotion of environmental protection, and resource management concepts and methods. This is done with the overall objective of achieving sustainable business development that will in turn raise the quality of life of the Taiwanese people.

The BCSD Taiwan is one of only a very few Taiwanese NGOs actively participating in sustainable development activities of the international community. Shortly after establishment, it joined the World Business Council for Sustainable Development (WBCSD) as one of the Global Network Partners and to serve as a liaison with related business organizations in the international community.
