





- Reflect the market value of our products and services and the cost of CDP operating our disclosure systems 反映CDP產品和服務的市場價值,以及營運揭露系統的成本
- The need to improve the user experience as well as to retain and grow the expertise in the organization 需要改善用戶體驗,以及發展組織內的專業知識
- Any changes to the benefits Disclosing companies receive? 揭露企業獲得的利益?
  - Globally, CDP has made considerable improvement in expanding CDP data coverage and materiality of questionnaire. In the future, we will focus on more improvement on Disclosure Platform, Scoring and Data. 在全球範圍內,CDP 在擴大數據覆蓋範圍和問卷內容的重大性已取得長足進步。 未來,我們將專注於在系統穩定性、評分和數據洞見方面進行更多改進。
